## **Organizational Context**

Under the administrative supervision of the Oversight Commissioners for Prosecution Department and the overall supervision of the Board of Commissioners, the Program Manager/Chief Prosecutor will perform the following duties.

## Functions / Key Results Expected

- Manage and supervise the Prosecution / Legal Department to ensure delivery of the Commission's mandate to prosecute all acts of corruption;
- Serve as the Legal Advisor to the Commission;
- Liaise with the Department of Monitoring and Investigation and provide legal assistance and direction to all ongoing investigations;
- Provide Legal Opinions and Briefs on Investigation Dockets;
- Liaise closely with the Ministry of Justice for the prosecution of cases, and collaborate to obtain indictments;
- Serve as lead legal Counsel of LACC in prosecution of offenders who for any reason(s) may escape the actions of the Ministry of Justice;
- Supervise the care and handling of prisoners and witnesses as well as lead and direct appeals of corruption cases
- Liaise with investigation and Assets Recovery and Mutual Legal Assistance (MLA) Section of LACC in providing legal advice on asset recovery and the MLA;
- Continuously remain in contact with witnesses and ensure their legal protection and care
- Prepare quarterly, semi-annual or Annual Reports for the Legal Department;
- Undertake other duties and responsibilities as may be assigned from time to time for the smooth implementation of LACC objectives.
